INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of Muskoka Bible Foundation which comprise the statement of financial position as at December 31, 2021 and the statement of operations and changes in net assets and statement of cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the entity as at December 31, 2021 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the entity in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NATURE OF OPERATIONS

Muskoka Bible Foundation ("MBF") was incorporated without share capital by letters of patent under the Canada Corporations Act on June 19, 2007. MBF is a registered charity under the Income Tax Act (Canada) and as such, is exempt from income tax and is able to issue donation receipts for income tax purposes.

MBF operates in conjunction with Muskoka Bible Centre Inc. ("MBC Inc."), Muskoka Ministry Centre ("MMC"), and Muskoka Bible Ministries ("MBM").

1. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations.

Change in Accounting Policy

Financial Instruments Originated or Exchanged in a Related Party Transaction

MBM applied the amendments to FINANCIAL INSTRUMENTS, Section 3856, relating to the recognition of financial instruments originating or exchanged in a related party transaction.

Under these new requirements, such a financial instrument is initially measured at cost, which is determined depending on whether the instrument has repayment terms.

Subsequent measurement depends on the initial method used and is usually at cost less any reduction for impairment.

The adoption of these new requirements had no impact on MBM's financial statements.

These financial statements include the following significant accounting policies:

a) Use of Estimates

The preparation of financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions based on currently available information. Such estimates and assumptions affect the reported amounts of assets and liabilities as at the date of the financial statements and the reported amounts of revenues and expenses during the year. Actual results could differ from these estimates.

b) Cash and Cash Equivalents

Cash and cash equivalents consist of cash held in the bank account.

1. SIGNIFICANT ACCOUNTING POLICIES - Continued

c) Revenue Recognition

MBF follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which related expenses are incurred. Unrestricted contributions are recognized as revenue when they are received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Interest income is recognized as revenue when earned.

d) Contributed Services

Volunteer services contributed to MBF in carrying out its operating activities are not recognized in these financial statements due to the difficulty in determining their fair value.

e) Non-Monetary Transactions

Non-monetary transactions of commercial substance are measured at the fair value of the instrument acquired.

f) Financial Instruments

Measurement of Financial Instruments

MBF initially measures all of its financial assets and liabilities at fair value and subsequently measures all of its financial assets and liabilities at amortized cost, except for certain balances with related parties, which are measured at carrying value.

Financial assets measured at amortized cost include cash and the bonds. Financial liabilities measured at amortized cost include accounts payable and accrued liabilities.

MBF has no financial assets measured at fair value and has not elected to carry any financial asset or liability at fair value.

Impairment

Financial assets measured at amortized cost are tested for impairment when events or circumstances indicate possible impairment. Write-downs, if any, are recognized in the excess of revenues over expenses and may be subsequently reversed to the extent that the net effect after the reversal is the same as if there had been no write-down. There are no indicators of impairment in the current year.

With the exception of the interest bearing demand loan and the bond receivable, all other amounts due from (to) related parties are non-interest bearing and have no specified terms of repayment.

MBF provides short-term financing to MMC in the form of an interest bearing, due on demand loan. The balance outstanding as at December 31, 2021 was \$210,000 (2020 - \$210,000). Loans of this nature bear interest at 2%.

3. FINANCIAL INSTRUMENTS

Risks and Concentrations

MBF is exposed to various risks through its financial instruments. The following analysis provides a summary of MBF's exposure to and concentrations of risk at December 31, 2021:

a) Credit Risk

Credit risk is the risk that one party to a financial instrument will cause financial loss for the other party by failing to discharge an obligation. MBF is not exposed to significant credit risk. There has been no change in the assessment of credit risk from the prior year.

b) Liquidity Risk

Liquidity risk is the risk that MBF will encounter difficulty in meeting obligations associated with financial liabilities. MBF is exposed to this risk mainly with respect to its accounts payable and accrued liabilities. MBF manages this risk by generating sufficient cash flow from operations and by managing its working capital. There has been no change in the assessment of liquidity risk from the prior year.

c) Market Risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk, and price risk. MBF is exposed mainly to interest rate risk as follows:

i) Interest Rate Risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. As described in Note 2, MBF is exposed to interest rate risk with respect to the related party interest bearing demand loan and the bonds. The exposure to this risk fluctuates as the balances and related interest rates change from year to year.

4. CONTINGENCIES

MBF is contingently liable as guarantor to the operating line of credit of MMC. The operating line of credit has an available limit of \$800,000, the balance of which was \$90,219 at December 31, 2021 (2020 - \$Nil).

5. IMPACT OF COVID-19

On March 11, 2020, the World Health Organization declared the outbreak of COVID-19 a pandemic. In many countries, including Canada, many businesses have been forced to cease or limit operations for extended or indefinite periods. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services, have triggered significant disruptions to businesses worldwide. MBF, together with MBC Inc., MMC and MBM, have been active in monitoring and assessing the impact of the pandemic on operations and have taken necessary steps to reduce expenditures where appropriate. It is not possible to reliably estimate the duration and severity of these consequences as well as their potential impact on the financial position and results of operations for MBF and the others in the group in future periods.
